Vaccines: A major topic for Dr. Locke

Questions about COVID-19 vaccinations from community members were the lead topic for Dr. Locke at today's Board of County Commissioners meeting. Regarding the new variants of the COVID-19 virus, Dr. Locke said there are actually multiple variants as viruses are always mutating. It is unlikely that any virus could mutate enough to become resistant to the vaccine. In response to a question about the possibility of some medical organizations requiring staff to get vaccinations, Dr. Locke said there are no organizations mandating that staff get vaccinated. "We are depending on the vaccine to sell itself," he said. Even if there are some healthcare workers who say they don't want the vaccine, we think most will embrace it over time. While some health care organizations will require a vaccine to protect patients, that's not likely to happen anytime soon, Locke said. Regarding who gets the vaccine in the next priority group, Locke said the process of developing priority schemes has been in the works for several months. The Advisory Committee on Immunization Practices (ACIP) came out with specific recommendations for Phase 1a, 1b and 1c. "We follow the priorities set by the State," said Dr. Locke. So far, about 66% of those on the 1a priority list have been vaccinated. "By the middle of January, we will start vaccinating people on the 1b list to include individuals who are 75 years of age and older and certain essential workers," said Locke. "The second dose of the vaccine will be given next week to those from Priority Group 1a who have received the first dose."

One question brought up the issue of age differences between a married couple putting one in priority group 1b and the other person in group 1c. Is it possible for a husband and wife with a slight age difference and living in the same household to be vaccinated the same time? Dr. Locke said he is anticipating that judgement calls for situations like this will be made. "We want to vaccinate people at the same time and will try to cluster together people living in the same household.

The state Department of Health is working on a program called PhaseFinder that will be available online for people to sign up to get an appointment for a vaccination. Plans are to include the program on the
