Weekly report from County Health Officer

At today's Board of County Commissioner's meeting, Dr. Locke said that vaccination rates are steadily increasing, limited only by supply. "Each month, vaccine supplies will improve, but not until April or May at the earliest," said Locke. "If we do everything right, we can head into a stable period or we could head into a fourth wave," Locke said. "It's up to us." We need to intensify what we are doing, especially with masking. The protection rate is highest with a well-fitting mask. Double masking is effective and high-quality cloth masks are effective. Two to three layers are the best as are masks made with tightly woven fabric.

Commenting on people who seem to be hesitant about getting vaccinated, Dr. Locke said to just give it time. "It's not unreasonable for people to be hesitant. Now, 71 percent of the population has expressed a desire to get vaccinated."

Emergency Management Director Willie Bence reported that recruitment continues for medical and non-medical volunteers in anticipation of mass vaccination events. "We will need all the help we can get." Inslee announces reopening of some schools

Gov. Inslee announced today that some schools in Washington State will be opening for in-person instruction. The number of days students can be in the classroom will be increasing, Inslee said. Parents will still have the right to keep kids at home and continue to get their education online, he said. Currently, 175 schools have safely re-opened. Specific school districts set to reopen were not named. Last week, the CDC came out with new guidance for schools. More funds authorized for assistance programs

Gov. Inslee also announced additional aid for business and rental assistance. This will authorize the Dept. of Commerce to distribute another \$87 million for additional rental and business assistance programs. Go to https://www.commerce.wa.gov for more information. The funds come from the state's Disaster Response account and are meant to build on the state's previous commitments while waiting for additional federal aid expected to become available in the spring.

Update on vaccine distribution

According to information released by the Washington Dept. of Health (DOH) last week, the supply of vaccine from the federal government is the biggest challenge for the state. After requesting more than 440,000 doses of vaccine to include 281,100 first doses and 165,750 second doses, just over 200,000 doses were received from the federal government. The Dept. of Health did receive a three-week allocation forecast that includes a combination of both first and second doses and is subject to change as vaccine availability changes. For this week the allocation forecast is 206,125 total doses; for the week of Feb. 21, 240,620 total doses and for the week of Feb. 28, 242,360 total doses. The DOH will be developing a multi-week strategy and hopes to have the plan in place in coming weeks.
