## Special Election: Tuesday, February 11, 2020

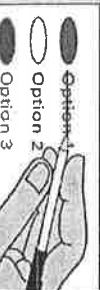
### Instructions

#### Marking Your Ballot



Fill in the oval to the left of your choice with a dark pen. Vote for one. If you vote for more than one, that race or measure will not be counted. To vote for a candidate not on the ballot, print the name on the line and fill in the oval to the left.

#### Making A Correction



If you make a mistake, draw a line through the entire candidate's name or response. To vote for another candidate or response, fill in the oval to the left of your new selection.

#### Additional Information

Sign and date the voter's declaration on the return envelope. For a replacement ballot, contact the Jefferson County Auditor's Office at (360) 385-9119. Deposit your ballot in a ballot drop box no later than 8:00 p.m. Election Day or mail. It must be postmarked on or before Election Day. ##### REPLACEMENT EDUCATIONAL PROGRAMS AND OPERATION LEVY

The Board of Directors of Quilcene School District No. 48 adopted Resolution No. 1: 2019/2020, concerning a proposition to finance educational programs and operation expenses. This proposition would authorize the District to levy the following excess taxes, in place of an expiring levy, on all taxable property within the District, for support of the District's educational programs and operation expenses not funded by the State of Washington:

##### CAPITAL LEVY TO IMPROVE SCHOOL FACILITIES

The Board of Directors of Quilcene School District No. 48 adopted Resolution No. 2: 2019/2020, concerning a proposition to finance improvements to school facilities. This proposition would authorize the District to levy the following excess taxes, on all taxable property within the District, to construct a new bus barn to replace the existing bus barn, redesign and reconfigure student drop off and pick up area, and conduct pre-construction activities for a replacement elementary school building:

#### PROPOSITION NO. 1 BRINNON SCHOOL DISTRICT NO. 46 EDUCATIONAL PROGRAMS AND OPERATIONS LEVY

The Board of Directors of Brinnon School District No. 46, Jefferson County ("the District"), adopted Resolution #258-19 concerning a proposition to finance its educational programs and operations expenses. This proposition would authorize the District to levy the following excess taxes, in place of an expiring levy, on all taxable property within the District in support of the District's general expenses of educational programs and operation, including funding for instructional programs beyond the state minimum instructional offerings, staffing ratios, program components, professional learning allocations, and student and program support.
