The elected Commissioners of Jefferson County Fire Protection District No. 4 adopted Resolution No. 2022-10 on December 13, 2022, which authorized putting before the Fire Protection District's qualified voters a proposition that would, if approved, establish a regular property tax levy of \$1.50 per \$1,000.00 of assessed valuation for the support of the General Fund maintenance and operations expenses of the Fire Protection District, for the purpose of computing the limitations for subsequent levies beginning in 2023 for collection in 2024. (This proposition shall not be construed to authorize an excess levy and shall be subject to otherwise applicable statutory limits.)

Jefferson County Fire Protection District #4 is placing a levy lid lift proposition on the February 14, 2023, ballot. This proposition will maintain the current level of fire protection. This measure will authorize the property tax levy rate of \$1.50 per \$1,000 of assessed valuation.

Approval of the levy will allow the District to maintain the current level of fire protection. The District will also use the revenue from this levy to maintain fire protection for call volumes increase. The District has seen a 62% increase in call volume over the last six years. The current levy rate is inadequate to support continuing levels of service. Approval would allow the District to maintain and improve an adequate level of fire protection. If approved, the fire levy on a \$250,000 assessed valuation residence will not exceed \$375.00 yearly or approximately \$31.25 monthly or an increase of \$11.67 for fire protection.
